## 11 June 2019 Unapproved Meeting Minutes

There were 11 fire runs in the month of May: Stockbridge 3: 1 ambulance assist, 2 lines down.Waterloo 2: 2 ambulance assist; White Oak, 2: 2 ambulance assist; Bunkerhill 2: 2 PI accidents; Mutual aid 2: 1 CAFA and 1 Henrietta. There were 57 ambulance calls in the month of May with 6 cancellations for a total of 63 calls.

- Bids were looked at and discussed for sealing the parking lots. It was decided to table the decision until the meeting in July.
- Stowe and Beck stated the need for having the fire tanker painted and new shoots installed. Old paint is bubbling and chipping. Ulrey motioned with support from Kitley to have the painting done and new shoots installed at My Body Shop in Stockbridge for an amount to not exceed \$30,000. Aye/all; no/none. Motion carried.
